2016 STANDARD BEARERS: EXCELLENCE IN ENERGY CODE COMPLIANCE AWARD

The Institute for Market Transformation (IMT) and the International Code Council (ICC) will recognize jurisdictions and code officials using strategies that have proved successful in achieving building energy code compliance and energy reduction in a cost-effective manner. Energy code compliance refers to whether a building meets the provisions of the energy code during the phases of design and construction. Award recipients will receive a travel stipend to attend the 2016 ICC Annual Conference and Public Comment Hearings in Kansas City, MO., to be honored at the ICC Awards Luncheon. Winners will also be photographed and featured in a press release sent to national, trade, and local media. Award recipients will be profiled on the IMT and ICC websites and in partner newsletters.

ELIGIBLE ENTRIES—ENERGY CODE LEADER

Any code official who has shown dedication to improving compliance with building energy codes. Activities for improving compliance may include the implementation of unique programs or processes such as education and training programs for industry and staff, or instituting quality assurance procedures. Activities may also include involvement in code development and professional associations, and the promotion of energy codes to local or state elected officials, as well as outreach and assistance to code officials in other jurisdictions.

AWARD CRITERIA

A panel of judges assembled by IMT and ICC will evaluate entries based on:

- Contributions of the individual to improve compliance
- Potential for the individual's activities to be replicated elsewhere
- Length of time the individual has been involved with building energy codes
- Impact the individual has had on their jurisdiction and other locations
